hired to work with the Rules Committee. The new Civil Proceedings Rules (CPR) were drafted in 1998 and accepted by the Rules Committee. They were laid in Parliament subject to negative resolution in accordance with section 78 (4) of the Supreme Court of Judicature Act and became law in 1998. The original commencement date was January 1, 1999.

CIVIL PROCEEDINGS RULES 1998 - The Judiciary of Trinidad

These Rules provide a new code of civil procedure for the civil courts. They replace the Rules of the Supreme Court 1965 and the County Court Rules 1981. As well as the main body of the new rules (Parts 1-48), they also provide for certain specialist proceedings (Part 49) and transitional provisions (Part 51); the details of these are contained in practice directions.
